# Learn How to Comply with the new *Canada Consumer Product Safety Act (CCPSA)*

Health Canada has announced that the official date for implementation of the new *Canadian Consumer Product Safety Act (CCPSA)* — formerly known as Bill C-36 — will be June 20, 2011, after which new requirements will be mandated by law. The CCPSA creates new obligations for manufacturers, importers, and distributors of consumer goods in Canada.
